Thank you for your assistance with Mr. Palmer.


After discussing the matter with Pastor Matthews this is what we require of Mr. Palmer:

- 2) Removal from the internet web site "edwardtheapostle.org" **all specific** mentions of Solid Rock Church, and/or Pastors William & Mary Matthews, their family, members of the church, past or present, and ministry's and ministers associated with Solid Rock Church and/or Pastors William & Mary Matthews.
- 3) New printings/editions of the *Book of Edward: Christian Mythology* must be edited to **remove all** specific mentions of Solid Rock Church, and/or Pastors William & Mary Matthews, their family, members of the church, past or present, and ministry's and ministers, past or present, associated with Solid Rock Church and/or Pastors William & Mary Matthews.
- 4) *The Theft of Solid Rock Church Elk River, MN – A Legal Brief and Godly Wisdom, Spiritual Abuse, or Cult* not to be reprinted, and hence forth not to be disseminated.
- 5) Mr. Palmer to not make any remarks orally through sermons and speeches about Solid Rock Church, and/or Pastors William & Mary Matthews, their family, members of the church, past or present, and ministry's and ministers, past or present, associated with Solid Rock Church and/or Pastors William & Mary Matthews.
- 6) Mr. Palmer to not make, or disseminate, any remarks published through printed or electronic mediums about Solid Rock Church, and/or Pastors William & Mary Matthews, their family, members of the church, past or present, and ministry's and ministers, past or present, associated with Solid Rock Church and/or Pastors William & Mary Matthews.
